Ordinance No. 23.008, An Ordinance of the Jefferson County Public Sewer District approving an Intergovernmental Agreement with the Jefferson County Department of the Collector of Revenue to Add the Special Assessments to the Annual Tax Bill for Each Property within the Boundary of any Sanitary Sewer Improvement Area, Withhold Two Percent (2%) for the Cost of Administering the Collection, and Reimburse the District the amount of the Assessment Collected Minus the Administration Cost. Staff Recommends approval of the ordinance. Vote Required.

Resolution No. 23-009, A Resolution of the Jefferson County Public Sewer District To Establish a Procedure to Disclose Potential Conflicts of Interest and Substantial Interests for Certain Officials.
